# Climate Change in the Commonwealth of Virginia Guest Speaker James L. Kinter, PhD Tuesday, January 5, 7 p.m.

"Everybody talks about the weather, but nobody does anything about it." This old saying neglects the fact that everybody is inadvertently doing something about the weather – we are changing it. The reality of global climate change is now undeniable and the likelihood is high that industrialization, urbanization and deforestation have caused most of the changes observed in the past 60 years. The citizens and businesses of the Commonwealth of Virginia are not exempt from the changes Earth will experience during the rest of this century.

Climate change is certainly going to be an increasingly important topic as the Biden administration addresses the issue. Find out what is happening here in Virginia from our guest speaker for the evening, George Mason University professor, Dr. James Kinter.

He will describe Mason research that is focused on these topics, emphasizing what we have learned about predicting future weather and climate in the mid-Atlantic region and what remains to be done to advance our understanding to actionable predictions.

Dr. Kinter is Director of the Center for Ocean-Land-Atmosphere Studies (COLA), which conducts research on climate variability and predictability from days to decades, focusing on phenomena such as droughts and floods, monsoons, El Niño, and climate change.

# **Highlights of Recent Branch Events**

# **November: Exploring Social Justice**

Our November 16, 2020, virtual program was a first in joining with two other local organizations to feature dynamic community leaders to discuss hot topics. The meeting was a great success with 57 attendees.

We joined the Optimist Club of Greater Vienna and the Virginia State Organization, Delta Kappa Gamma Society International, *Alpha Nu* Chapter. Bettina Lawton, a community activist, moderated the discussion and incorporated questions from attendees.

#### **Social Justice in Policing**

Hunter Mill District Supervisor Walter Alcorn and Shirley Ginwright, Chair of the Fairfax County Communities of Trust, addressed questions of police policy and practice and improving police relations with the Fairfax County community. Fairfax County Police Chief Edwin Roessler Jr. attended the program and offered comments. According to Supervisor Alcorn, ongoing county initiatives include training programs in de-escalation and a pilot program for how to respond to 911 calls. Expanding the use of body cameras has been slowed by the pandemic and limited resources. Interestingly, it is not the cost of camera hardware that is the obstacle, but staffing to review footage.

Ms. Ginwright detailed many of the activities of the Communities of Trust and how they identify and act

on issues. Two topics of increased importance are providing programs for young people and the reluctance of immigrant communities to raise concerns due to fear of ICE. She also talked about changing the role of school resource officers. Communities of Trust meetings are open to all.

Shyamali Hauth, a staffer for Supervisor Alcorn, supplied ongoing answers and links through the chat feature, as did Ms. Ginwright.

#### **Social Justice in Education**

Sean Perryman, President of the Fairfax County NAACP, and Leona Smith-Vance, Director of Equity and Family Engagement at Fairfax County Public Schools, each spoke to education issues. In response to a question about equity at the highly-rated Thomas Jefferson High School for Science and Technology, Mr. Perryman said not only the student selection process needs revision. He cited the dearth of diverse teachers and some of the steps being taken to make hiring decisions more objective and inclusive.

Ms. Smith-Vance is the first Director of Equity and Family Engagement, a new FCPS initiative. The office is reaching out to parents of students and the community at large to raise issues and help develop policy. She noted that racism is currently not adequately addressed in written policy.

# **Public Policy Matters:**

# Notes from Zoom Meeting with Sen. Kaine's Staff on December 10, 2020

AAUW Reston-Herndon Area Branch hosted other branches at a Zoom meeting with two senior staffers for Senator Tim Kaine to discuss priorities for 117<sup>th</sup> Congress. There were 27 attendees.

Moderator and branch president Janine Greenwood asked if there was any news on the bipartisan COVID Relief Bill. Legislative Correspondent Nigel Stinson said the Senate was negotiating now and that COVID was at the forefront of the administration's priorities along with getting the economy under control.

Stinson also said Sen. Kaine joined Sen. Patty Murray (D-WA) to introduce the Child Care is Essential Act. This legislation would create a \$50 billion Child Care Stabilization Fund within the existing Child Care and Development Block Grant program. AAUW recognizes the important role of child care issues in achieving women's workplace and economic equity.

Legislative Correspondent Anna Przebinda, who covers



women's issues for Sen. Kaine, responded to Greenwood's characterization of the recession as a "she session" because it was an economic setback for women. Przebinda said women in care-giving roles have been hit by the pandemic with challenges and interruptions in careers, labor supply and with day care closings.

Moderator Greenwood also brought up the Ft. Hood sexual harassment case. AAUW Springfield Branch member Marcy Leverenz recalled AAUW supporting legislation that would take sexual harassment/assaults of military personnel by military out of the chain of command.

Although the new administration has multiple problems to solve, Sen. Kaine's staffers said its priorities are to enhance and fix the ACA; pass COVID-19 relief; control the economy; put school funding and child care at top of the list; and strengthen the Voting Rights Act. With those hopeful words, the Zoom meeting ended.


# January 9, 2021: Local Governments' Efforts on Diversity, Equity, and Inclusion


