There are presently 23 active AAUW branches in Virginia. The state is divided geographically into four districts. Branches within the districts meet twice a year. Vernon, Reston-Herndon, Springfield/Annandale, and Woodbridge are in the <u>Northern District</u>.

#### **Report on Liberty Amendments Month Celebration**

#### Vienna Area AAUW and the Town of Vienna

Vienna Area AAUW once again took part in the Town of Vienna's Liberty Amendments Month celebrations.

On July 13, the branch recognized the passage of the 19th Amendment with *Book Talks for Tweens and Teens: The Struggle for the 19th Amendment.* Five books connected to the 19th Amendment (fiction and nonfiction) were featured in the five minute talks given to small groups of teens at the teen center in Vienna. There were approximately twenty young teens (boys and girls) at the summer camp.

The branch volunteers used a variety of devices including posters, props, costumes, and role playing as they rotated from group to group. The session ended with the distribution to the teens of Ben and Jerry's ice cream gift cards (donated by Vienna Town Businesses) and book marks listing the five books and branch information.

The branch will present copies of the books to Andréa Fernandes, Youth Services Manager at the Patrick Henry Library, during our Open House on September 9th; the books will supplement the single copies of these books now available in the Fairfax County Public Library system, and will include book plates recognizing Vienna Area AAUW for the gifts.

## VIENNA BRANCH BYLAWS UPDATE

National AAUW members voted in spring 2023 by more than a two-thirds to approve amendments to the AAUW Bylaws.

The National AAUW Bylaws amendments require that state and branch affiliates make mandatory conforming changes to the first seven articles of their bylaws, which do not require branch board or membership approval. I have revised the Vienna Area Branch Bylaws to conform to an AAUW Model Affiliate Bylaws document issued by AAUW. The revised bylaws are published on the state website.

We began in January 2023 and we will resume on September 17th with topic 7, *Iran at a Crossroads*, and October 15th with topic 8, *Climate Migration*. The Foreign Policy Association Great Decisions Briefing Book provides background material and discussion questions for each topic. We use the Kindle version of the 2023 briefing book or the printed version. You may order your Kindle version on Amazon and it should be about \$25. If you choose the printed version, it is available on the FPA website, fpa.org, where the cost is about \$35 plus shipping. Members of the group also contribute about \$5 toward the cost of the official DVD containing the lectures.

Members may sign up to host or to bring refreshments throughout the year. Hosting requires access to a DVD player and seating for 10-12 members. Those bringing refreshments coordinate with our host.
